Re: Puerto Rico Postponement for the Filing and Payment Deadline for the 2021 Tax Year

Dear Commissioner Rettig and Assistant Secretary Mazur:

The Puerto Rico State Society of Certified Public Accountants (PR State Society of CPAs) recognizes and appreciates the efforts the Department of the Treasury ("Treasury") and the Internal Revenue Service (IRS) have made to provide relief to taxpayers in Puerto Rico affected during 2022 (the 2021 tax year) affected by severe storms, flooding, and landslides that reside or have a business in municipalities of Cataño, Dorado, Toa Baja, Vega Alta, and Vega Baja¹.

On the evening of Wednesday April 6, 2022 an Island-wide blackout was experienced in Puerto Rico². Accordingly, Power has being slowly restored, but nearly 420,000 customers continue to lack electricity as of about 4:00 p.m. on Friday April 8, 2022, out of a total of more than 1.4 million customers, according to poweroutage.us, which tracks power interruptions³. Accordingly, the Puerto Rico Treasury Department issued Administrative Determination 22-03 to grant additional time to file the corresponding Puerto Rico Income Tax Returns due on or before Monday April 18, 2022⁴.

Thus, in the current environment, it is simply not possible for many taxpayers and their tax advisers to meet their filing and payment obligations that are due on April 18, 2022. Further, it's important to note that for calendar year 2021 the changes made to the Child Tax Credit, including easier access for Puerto Rico residents, will cause an unusually high amount of federal returns to be filed by Puerto Rico residents.

Hence, we respectfully urge Treasury and the IRS to act immediately to provide tax filing and payment relief for taxpayers and tax professionals affected by the ongoing blackout in Puerto Rico. Specifically, we request that all 2021 Federal income tax, information returns, and payments (e.g., extension and estimated payments) originally due April 18, 2022 be granted additional time to file and pay until June 15, 2022.
