Dear Mr. Pantoja Rodríguez:

In accordance with the Rules, Regulations and Orders Review Policy of the Financial Oversight and Management Board for Puerto Rico (the “Oversight Board”), established pursuant to Section 204(b)(4) of PROMESA, we have reviewed the proposed *Internal Revenue Informative Bulletin No. 26-0X* (the “Proposed Informative Bulletin”) to be issued by the Puerto Rico Department of Treasury (“PRDT”). The Proposed Informative Bulletin seeks to notify the fiscal year 2027 distribution percentage of the municipal sales-and-use tax collected by the PRDT on mail order sales of taxable items from merchants that do not have a commercial location in Puerto Rico pursuant to Sections 4020.08, 4020.10 and 6080.14 of the Puerto Rico Internal Revenue Code of 2011 and Article 6080.14(a)(2)-1(b)(2) of the *Regulation of the Puerto Rico Internal Revenue Code of 2011*.

After reviewing the Proposed Informative Bulletin, the Oversight Board designates it as “Approved.”

Please note the Oversight Board’s review is solely limited to the Proposed Informative Bulletin’s compliance with the applicable Fiscal Plan and no other matters. For the avoidance of doubt, the review performed by the Oversight Board does not constitute a legal review under applicable laws, rules, and regulations, both federal and local, including without limitation, compliance with any applicable labor laws, rules and regulations. Any material changes to the Proposed Informative Bulletin must be submitted to the Oversight Board for its review and approval **prior to adoption and publication**.
